The **Performer** is the artiste listed above and signing this agreement having read and understood this document in its entirety. **Performers** under the age of 18 must have a counter signatory from their legal parent or guardian.

The **Client** is a person(s) including legal entity or company offering paid or unpaid work to the **Performer**.

# 1. The Agreement

This agreement is between the **Performer** and **Brill Talent Agency**.

The **Performer** having the legal right to enter into this agreement or, in case of a minor, agreed by the legal guardian with parental responsibility and legal right to enter into this agreement.

The length of this agreement will be for a period of **ONE year** or until the **Performer** gives one month's notice of intention to terminate this agreement and a signed agreement from **Brill Talent Agency** confirming the end of this agreement has been received. **Brill Talent Agency** will continue to collect commission on work gained through the **Performer's** time with **Brill Talent Agency** at the agreed rate, as set out below. Any relevant royalties and proceeds of merchandising and any other income will be obtained in perpetuity.

On signing this agreement **Brill Talent Agency** will undertake the appointment as the **Performer's SOL** agent. The **Performer** may NOT enter into agreements with other parties.

**Brill Talent Agency** will deduct 20% from all **Performer's** earnings. The **Performer** will ensure all payments are made directly to **Brill Talent Agency**. The payment will then be forwarded to the **Performer** less commission. In cases of international payments, all taxes will be deducted accordingly in line with law and legislation.

- **Brill Talent Agency** agrees to submit the **Performer** for any relevant work and to provide them with the best service they can.
- **Brill Talent Agency** will do their best to maintain good, solid relationships with their clients where possible
- **Brill Talent Agency** does not guarantee any work or auditions.
- The **Performer** will source their own travel arrangements and accommodation to auditions and castings, if required, and for any contracts where this is not included within the remuneration package.
- The **Performer** will show good punctuality, professionalism and manners all times.
- The **Performer** will act as an ambassador for **Brill Talent Agency** and will not mention, pass comment or refer to **Brill Talent Agency** or its staff in a derogatory manner to anyone for any reason.

## 2. UK GDPR / Personal Information

If you are unhappy, disagree or do not understand the personal information section below. You must not enter into this agreement.

Personal information will be held with your permission by the **Brill Talent Agency**. To attract castings, roles and performance opportunities, **Brill Talent Agency** may share some, part or all personal information supplied to **Brill Talent Agency** within your questionnaire or held within your Spotlight profile with third parties at their discretion. **Brill Talent Agency** will contact you by email, phone or text with the details of communications received and other possible connections to work either paid or non-paid. This will also include all **Brill Talent Agency** promotional material.

Your information will be retained, until you terminate this contract by the agreed process set out in this agreement and you have received confirmation of the date of termination from **Brill Talent Agency**.

### 3. Safety

All **Performers** must take appropriate cautions whilst entering unknown situations. We will do everything to ensure a casting is safe for ALL our **Performers** before submitting their details for a casting/audition or sending out casting/audition invites. However, should a casting/audition not be as advertised upon arrival, you should contact us immediately.

- **Brill Talent Agency** must know when you are attending auditions, castings, or bookings.
- **Brill Talent Agency** must be kept informed of where you are during an audition, casting or booking at all times including any changes to your schedule.
- Children must not be left unattended without verified licenced chaperones and it is advised that a note of their name and licence be taken.
- Do not enter into any agreement, any further meeting or change of venue until you have agreed with **Brill Talent Agency** that this is the appropriate course of action.
- Under no circumstances are **Performers** to be asked to remove clothing for camera or any other reason other than for costume change (which should be in a private area) or unless it has already been agreed in writing and forms part of the contract between the **Performer** and the **Client**. Nor should **Performers** be asked to act in a manner they feel inappropriate. If this happens for any reason the **Performer** must not continue and consult with **Brill Talent Agency** immediately.
- **Performers** will under no circumstances be asked to smoke cigarettes or perform any other activity which may be detrimental to their health. **Performers** may be asked to simulate smoking herbal cigarettes, but this will be stipulated and agreed before any contract is signed with the **Client**.
- **Performers** must be made aware of any sensitive text or scenes that they may be asked to perform prior to attending any booking / audition / casting including learning lines etc.

### 4. Spotlight

A **Performer** agrees to have their details placed on the Spotlight forum at cost to them.

**Brill Talent Agency** will not profit from your registration and will remain your point of contact for Spotlight to contact you. **Brill Talent Agency** reserves the right to terminate a contract should a **Performer** allow their Spotlight membership to expire. **Brill Talent Agency** must contact the **Performer** and give them the opportunity to re-activate their membership before terminating their contract.

### 5. Photographs and Other Media

Any and all photographs / videos or media taken by or presented to **Brill Talent Agency** shall remain the property of **Brill Talent Agency** along with the right to use them in any way **Brill Talent Agency** feels appropriate. **Performers** will take responsibility of ensuring they have the correct permissions for all media presented to **Brill Talent Agency**.
